

June 2021 Quarterly Compliance Report

Understanding the Administrator's Quarterly Compliance Report

Clause B102 of the National Health Reform Agreement 2011 requires the Administrator to publish details of Commonwealth, State and Territory compliance with the data requirements specified in the <u>Administrator's Three Year Data Plan 2020-21 to 2022-23</u>. Clause A152 of the Addendum to the National Health Reform Agreement 2020-21 to 2024-25 requires the Administrator to publish additional information in the compliance reports.

The format of the Quarterly Compliance Reports follows a standard structure, with relevant data requirements reflected in each quarter. Further information on requirements can be found in the Administrator's 2020-21 Data Compliance Policy.

Executive Summary

Seven States and Territories (the States) submitted 2020-21 Service Agreements to the Administrator. Victoria did not submit any 2020-21 Service Agreements to the Administrator. This compares to last financial year where Victoria submitted their Service Agreements in November 2019.

Due to the volatility of public hospital services in 2020-21, and the interplay between Commonwealth NHR funding and the National Partnership on COVID-19 Response, the latest NHR activity estimates (excluding COVID-19) may not align with the latest version of 2020-21 Service Agreements.

All States submitted their 2020-21 Quarter Three data submissions by the due date. Only two States made minor resubmissions in July 2021 compared to six States in 2019-20.

Monthly report submissions for 2020-21 were a positive highlight, with all States submitting reports on or before the due date. This enabled the Administrator to publish full financial year 2020-21 funding and payment reports by July 2021. This is the earliest that full financial year reports have been published.

Estimated State activity data submissions for 2021-22 were provided on time by five States, with the remaining three provided within one week of the due date. This compares with delays of up to three weeks for the same reporting period in 2019-20.

The Administrator will continue to work with States on providing greater transparency and consistency of public reporting in 2021-22, including through the Quarterly Compliance Report.

The Data Compliance Policy 2021-22 has been circulated to all jurisdictions, including already partially completed NHR Funding tables. Inclusion of the NHR Funding table within each 2021-22 Service Agreement will mean that those States that are currently assessed as non-compliant, in relation to NHRA ABF and Block funding requirements, will be assessed as compliant.


