

September 2023 Quarterly Compliance Report



Understanding the Administrator's Quarterly Compliance Report

Clause B102 of the *National Health Reform Agreement 2011* (NHR Agreement) requires the Administrator to publish details of Commonwealth, State and Territory compliance with the data requirements specified in the *Administrator's Three Year Data Plan 2023-24 to 2025-26*.

Clause A152 of the Addendum to the National Health Reform Agreement 2020-21 to 2024-25 (the Addendum) requires the Administrator to publish additional information in the compliance reports on dates data is submitted or resubmitted by States.

The format of the Quarterly Compliance Reports follows a standard structure, with relevant data requirements reflected in each quarter. Further information on requirements can be found in the *Administrator's 2023-24 Data Compliance Policy*.

Executive Summary

2023-24 Service Agreements

Four out of eight States and Territories (hereafter States and Territories are referred to as States) submitted all 2023-24 Service Agreements to the Administrator, with Queensland (Qld) and South Australia (SA) providing partial submissions as at 30 September 2023. Of these submissions, three States provided all Service Agreements to the Administrator within the required 14 calendar days from finalisation or amendment. Qld and SA partially met the required timeframe. Western Australia (WA) did not provide their Service Agreements to the Administrator within 14 days of finalisation. However, we note that WA executed all Service Agreements before 30 June 2023 and publicly released them prior to advising the Administrator. New South Wales (NSW) and Victoria have advised their expected timeframe for Service Agreement provision is November 2023.

Of the 30 Service Agreements submitted to the Administrator, 15 align to current NWAU estimate submissions, compared to 25 of 39 in September 2022. While the 15 Service Agreements provided by Qld do not align to their current estimate submission, Qld have confirmed that their 'Window Two' Service Agreements (circa January 2024) will align.

2022-23 Annual Data Submissions

With respect to the timeliness of 2022-23 annual data submissions, eight out of eight States provided Submission A on time. Six of eight States provided Submission B on time, with NSW and the Northern Territory (NT) both providing submissions on 3 October 2023. The Australian Capital Territory (ACT) provided partial data files for both submissions, however they continue to work closely with the NHFB to finalise data requirements. Five States provided their Statement of Assurance on time, with NSW providing their submission on 6 October 2023.

Only Qld provided Private Patient Revenue data on time with the remaining seven State submissions outstanding as at 30 September 2023. Two of the four States that deliver Highly Specialised Therapies provided submissions on time, noting that NSW's submission was partial as at 30 September and WA provided a submission on 6 October 2023. All States have provided Sentinel Event data.

While the overall timeliness of the 2022-23 Annual Data Submissions has been reasonable, it has declined on the previous year. In 2021-22, all eight States provided Submission A, Submission B and Statements of Assurance on time.

Monthly Reporting

Monthly reporting continues to be completed by States on or before the due date of the 15th of the following month.

Funding Transparency

The Administrator will continue to work with States on achieving greater transparency and consistency of public reporting throughout 2023-24, and report progress, including through the Quarterly Compliance Report. The Addendum also includes the requirement for the Administrator and Australian Institute of Health and Welfare to work with all Parties to improve consistency and transparency of data and enable the Administrator to provide an annual report on Maintenance of Effort.

The Administrator's Annual Report 2020-21 - Maintenance of Effort was published in March 2023 and the Administrator's Annual Report 2021-22 - Maintenance of Effort was published in early July 2023. Both reports found that the Commonwealth and States have maintained, at a minimum, 2018-19 levels of funding for public hospital services through the National Health Funding Pool (the Pool). However, the report also identified inconsistencies in the level of in-scope and out-of-scope funding transacted through the Pool as well as pricing and activity information published in LHN Service Agreements.

Ahead of the 2022-23 Maintenance of Effort Report, the Administrator and NHFB have been working closely with States to address these inconsistencies.


